**FISHERIES (AMENDMENT) ACT 1997 (NO. 23)****NOTICE OF DECISION RELATING TO AQUACULTURE LICENCE APPEAL**

Appeal against the decision of the Minister for Agriculture, Food and the Marine to revoke an Aquaculture Licence to Frank Burke to cultivate rainbow trout on Site Ref. T09/084 in Rafor, Athenry, Co. Galway.

Further to the above appeal, the Aquaculture Licences Appeals Board has decided as of 06 September 2024 to ANNUL the decision of the Minister and to REFUSE TO REVOKE an Aquaculture Licence to the Applicant for the above referenced Site.
