### FISHERIES (AMENDMENT) ACT 1997 (NO. 23) NOTICE OF DECISION RELATING TO AQUACULTURE LICENCE APPEAL

Appeal against the decision of the Minister to grant a licence to Bantry Marine Research Station Ltd to cultivate various aquatic plants using longlines on the sub-tidal foreshore, on site T05/640A adjacent to Dooneen Pier, along the north shore of Dunmanus Bay, Co. Cork.

Further to the above appeal, the Aquaculture Licences Appeals Board has decided as of 26 September 2024 to CONFIRM the decision of the Minister to GRANT an Aquaculture Licence to the Applicant for the above referenced Site. The reasons for this decision are elaborated on the Board's website at:
