Hi Ciara,

I have been in contact with the relevant people and been informed as follows:

A significant portion of the pier at Gearhies is in charge of Cork County Council. The Council does not have a registered title to the property. Current searches have not revealed an unregistered title to the property either. That is not in itself unusual, as there are many piers within the county for which the Council does not have a documentary title. As the pier is in charge of the Council, it maintains it and carries out capital works to it from time to time. In the circumstances, and having particular regard to expenditure on the pier, the Council is of the view is that it has a beneficial interest in the Gearhies pier.
