FISHERIES (AMENDMENT) ACT 1997 (NO. 23) NOTICE OF DECISION RELATING TO AQUACULTURE LICENCE APPEAL

Appeal against the decision of the Minister for Agriculture, Food and the Marine to refuse to grant an Aquaculture Licence to Foylantic Ltd to cultivate Pacific Oysters using bags and trestles on site T12/572A on the inter-tidal foreshore in Trawbreaga Bay, Co. Donegal.

Further to the above appeal, the Aquaculture Licences Appeals Board has decided as of 28 March 2024 to confirm the decision of the Minister to refuse an Aquaculture Licence to the Applicant for the above referenced Site. A person may question the validity of this decision by way of an application for judicial review under Order 84 of the Rules of the Superior Courts (S.I. No. 15 of 1986) in accordance with section 73 of the Fisheries (Amendment) Act 1997 (No. 23).
