**Appeal against determination of the Minister for Agriculture, Food and the Marine

Thank you for ALAB's letter of 24 June 2020 regarding our appeal against the Determination of the Minister dated 12 April 2019 discontinuing our entitlement to continue aquaculture operations pursuant to section 19A(4) of the Fisheries (Amendment) Act 1997 (as amended) (the "**Determination**") and regarding an amendment to the Licence to provide for the control of production by reference to a maximum Standing Stock Biomass ("SSB"), otherwise known as a Maximum Allowable Biomass ("MAB"). ALAB's letter of 24 June 2020 has requested Mowi Ireland to provide:

"copies of all records retained by MOWI Ireland regarding the annual harvested tonnage produced at Site T06/202 Deenish Island for the last 30 years or, if MOWI Ireland records do not subsist for that period, for such shorter period for which MOWI Ireland holds such records",

This letter provides all records requested as explained below and enclosed.

With regard to the time period for which records subsist, Mowi Ireland has operated at the Deenish site since 2008. In 2008 the ultimate parent in the Mowi Ireland group of companies, Comhlucht Iascaireachta Fanad Teoranta, acquired Silver King Seafoods Limited which had operated the site up until 2008. Mowi Ireland first stocked the Deenish site in 2010 and has no records regarding the Deenish site before this first stocking. Accordingly, this response provides the records from 2010 to date.

As noted in the appeal to ALAB of May 3rd 2019, there has been no harvesting under the meaning of the Licence (ie. no killing of live salmon that could lead to effluent discharge at the Deenish site) since Mowi Ireland began operating the Deenish site. Mowi Ireland's provision of the enclosed records is strictly without prejudice to the position that there is not an "annual harvested tonnage" at the Deenish site. Mowi Ireland has of course provided details of fish extracted from the Deenish site for harvest to the Department upon request or during inspections by the Department

Mowi Ireland's records are maintained electronically on a database using the MERCATUS Farmer software¹. Thus, Mowi Ireland has extracted the requested records from that database detailing all removals of pre-harvest stock since Mowi Ireland began operating the Deenish site. The pre-harvest stock is removed to be harvested and is reported in dead weight tonnages. Please note that the records include the trial period during which an increased stocking limit applied.

The ALAB request also references production at the Deenish site. For completeness, Mowi Ireland also provides the records of partially grown stock removed from the Deenish site for production from 2010 to date. This stock was removed from the Deenish site for further growth at other sites and is not included in the annual harvested tonnage.

For ease of reference, the tables below summarises the weights of fish which have been removed from the Deenish site since 2010 as described in the records listed in the Appendix.

The movement of live fish from the Deenish site to another site triggers a requirement for a Movement Approval Notice from the Marine Institute. The Movement Approval Notices in respect of each of these movements are also enclosed and are listed in the Appendix. Please note that the weights set out in the Movement Approval Notices are estimates prior to the movement. The table above and the record called "*Partially Grown Salmon Stock Live Movement Report*" sets out the accurate weights.

Mowi Ireland wishes to specifically draw ALAB's attention to the pre-harvest figure of 1,862.91 tonnes HOG for 2016. Mowi Ireland was asked by the Department on 13th February 2017 to provide the tonnage (dead weight) per harvest 2015 and 2016. In its response, Mowi Ireland incorrectly stated that 1,108.91 tonnes HOG was the harvest batch from the Deenish site in 2016. That figure should have been 1,862.91 tonnes HOG. Due to human error, removals of fish from the Deenish site which took place before 2 October 2016 were inadvertently excluded from the data extracted from the MERCATUS Farmer system and provided to the Department in response to the 13th February 2017 request. Given that the Minister's Determination relates to 2016, Mowi Ireland is forwarding a copy of this letter and the enclosed records to the Department to correct the Department's records.


As set out in Mowi Ireland's appeal to ALAB of May 3rd 2019, in 2016, pre-harvest stock was transported from the Deenish site to Castletownbere, where the live fish were pumped off into a mobile and temporary harvest station for killing. The fish and blood water entered a purpose built and food grade stainless steel HGV tankers which contain a mixture of ice and water and were then transported to a processing plant at Rinmore in County Donegal. This process was also applied to the 2014 pre-harvest stock. Since 2018, the appeal explains that pre-harvest stock are pumped from the pens at the Deenish Site onto a vessel, in which the fish are killed brought to the processing plant at Rinmore in County Donegal. There are no discharges of effluent or waste from the boat to the water and instead the blood water is treated on land at its registered waste water treatment plant at Rinmore, Co. Donegal.

Thank you for ALAB's letter of 24 June 2020 regarding our appeal against the Determination of the Minister dated 12 April 2019 discontinuing our entitlement to continue aquaculture operations pursuant to section 19A(4) of the Fisheries (Amendment) Act 1997 (as amended) (the "**Determination**") and regarding an amendment to the Licence to provide for the control of production by reference to a maximum Standing Stock Biomass ("SSB"), otherwise known as a Maximum Allowable Biomass ("MAB"). ALAB's letter of 24 June 2020 has requested Mowi Ireland to provide:

"copies of all records retained by MOWI Ireland regarding the annual harvested tonnage produced at Site T06/202 Deenish Island for the last 30 years or, if MOWI Ireland records do not subsist for that period, for such shorter period for which MOWI Ireland holds such records",

This letter provides all records requested as explained below and enclosed.

With regard to the time period for which records subsist, Mowi Ireland has operated at the Deenish site since 2008. In 2008 the ultimate parent in the Mowi Ireland group of companies, Comhlucht Iascaireachta Fanad Teoranta, acquired Silver King Seafoods Limited which had operated the site up until 2008. Mowi Ireland first stocked the Deenish site in 2010 and has no records regarding the Deenish site before this first stocking. Accordingly, this response provides the records from 2010 to date.

As noted in the appeal to ALAB of May 3rd 2019, there has been no harvesting under the meaning of the Licence (ie, no killing of live salmon that could lead to effluent discharge at the Deenish site) since Mowi Ireland began operating the Deenish site. Mowi Ireland's provision of the enclosed records is strictly without prejudice to the position that there is not an "annual harvested tonnage" at the Deenish site. Mowi Ireland has of course provided details of fish extracted from the Deenish site for harvest to the Department upon request or during inspections by the Department

Mowi Ireland's records are maintained electronically on a database using the MERCATUS Farmer software¹. Thus, Mowi Ireland has extracted the requested records from that database detailing all removals of pre-harvest stock since Mowi Ireland began operating the Deenish site. The pre-harvest stock is removed to be harvested and is reported in dead weight tonnages. Please note that the records include the trial period during which an increased stocking limit applied.

The ALAB request also references production at the Deenish site. For completeness, Mowi Ireland also provides the records of partially grown stock removed from the Deenish site for production from 2010 to date. This stock was removed from the Deenish site for further growth at other sites and is not included in the annual harvested tonnage.

For ease of reference, the tables below summarises the weights of fish which have been removed from the Deenish site since 2010 as described in the records listed in the Appendix.

The movement of live fish from the Deenish site to another site triggers a requirement for a Movement Approval Notice from the Marine Institute. The Movement Approval Notices in respect of each of these movements are also enclosed and are listed in the Appendix. Please note that the weights set out in the Movement Approval Notices are estimates prior to the movement. The table above and the record called "*Partially Grown Salmon Stock Live Movement Report*" sets out the accurate weights.

Mowi Ireland wishes to specifically draw ALAB's attention to the pre-harvest figure of 1,862.91 tonnes HOG for 2016. Mowi Ireland was asked by the Department on 13th February 2017 to provide the tonnage (dead weight) per harvest 2015 and 2016. In its response, Mowi Ireland incorrectly stated that 1,108.91 tonnes HOG was the harvest batch from the Deenish site in 2016. That figure should have been 1,862.91 tonnes HOG. Due to human error, removals of fish from the Deenish site which took place before 2 October 2016 were inadvertently excluded from the data extracted from the MERCATUS Farmer system and provided to the Department in response to the 13th February 2017 request. Given that the Minister's Determination relates to 2016, Mowi Ireland is forwarding a copy of this letter and the enclosed records to the Department to correct the Department's records.

As set out in Mowi Ireland's appeal to ALAB of May 3rd 2019, in 2016, pre-harvest stock was transported from the Deenish site to Castletownbere, where the live fish were pumped off into a mobile and temporary harvest station for killing. The fish and blood water entered a purpose built and food grade stainless steel HGV tankers which contain a mixture of ice and water and were then transported to a processing plant at Rinmore in County Donegal. This process was also applied to the 2014 pre-harvest stock. Since 2018, the appeal explains that pre-harvest stock are pumped from the pens at the Deenish Site onto a vessel, in which the fish are killed brought to the processing plant at Rinmore in County Donegal. There are no discharges of effluent or waste from the boat to the water and instead the blood water is treated on land at its registered waste water treatment plant at Rinmore, Co. Donegal.

We look forward to the processing of the appeal and we welcome having an opportunity to comment on any submissions which ALAB may receive with regard to the appeal.






