

# Screening for Appropriate Assessment of Wexford Harbour Aquaculture Licence Site T03/030A2

### ALAB Appeal Ref No. AP38/2019

## Appeal description:

Appeal against the decision by the Minister for Agriculture, Food and the Marine to grant (with variations) Aquaculture Licences to T.L Mussels Ltd. for the bottom cultivation of mussels at T03/030A2, B, C & E on the foreshore at Wexford Harbour, Co. Wexford.

#### Step 1 - Description of project/proposal and local site characteristics

#### Brief description of the project

TL Mussels Ltd. was granted an Aquaculture Licence for 5 sites in Wexford Harbour for the bottom cultivation of mussels in April 2002 (Aquaculture Licence reference number T3/30 (sites A2, B, C, E and F)). Site T3/30A2 is 8.2218 hectares in area.

The Minister decided to grant a variation licence for a 2.7435-hectare site hectare site to T.L Mussels Ltd. in September 2019 (Aquaculture Licence reference number T03/030A2).

The licence application is for the bottom cultivation of mussels only; mussel seed is collected and relayed from coastal sites in the Irish Sea, then left in situ for a period of between 12 to 24 months, until it reaches market size. During this period, sampling occurs to track stock quality (sampling increases in frequency nearing and during the harvesting period). Harvesting takes place using a mussel dredger and whilst harvesting can occur at any time of the year it most commonly occurs during the period from September through to April.

#### Brief description of the site characteristics

Wexford Harbour is located at the mouth of the River Slaney in County Wexford, on the southeast coast of Ireland. It is a large shallow bay, with areas of reclaimed land to the north and south created by dykes and drainage systems first built in the 19<sup>th</sup> century. These areas of land, known as the Slobs, are used for agriculture and are important for several bird species. The Slaney is the main freshwater input to the Harbour and its catchment area is notable for the high level of agricultural activity, including mainly dairy and tillage farming. The underlying geology of the upper and central Slaney catchment consists of granite. The bedrock geology of the middle and lower reaches of the River Slaney comprises slate, schist and greywacke.

The soils of the Slaney catchment are mainly Grey Brown Podzolics and Brown Podzols which are regarded as very fertile soil types.

#### Purpose of this document

TL Mussels Ltd. appealed the minister's decision on the 16<sup>th</sup> of October 2019 (ALAB reference number AP38/2019).

An Appropriate Assessment was carried out by DAFM prior to its decision to grant the licence. In this appeal, T.L. Mussels Ltd. in its response, dated 1 May 2024, to ALAB's Section 46 information request, dated 31 January 2024, submitted that a thorough screening exercise is required to determine that an Appropriate Assessment is actually required.

This document is to assist the Screening for Appropriate Assessment for the Aquaculture Licence Site T03/030A2 only and is based on the 8.2218-hectare site granted in 2002 (Appendix 1 Aquaculture Licence map).

This Screening for Appropriate Assessment report considers all potential cumulative impact existing, proposed and or permitted plans and projects, i.e. those plans and projects which could cause T03/030A2 in-combination effects.

Aquaculture licenced activities in Wexford Harbour were Screened for Appropriate Assessment in 2016; the Marine Institute (MI), on behalf of the Department of Agriculture, Food and the Marine produced a bay wide Appropriate Assessment Summary Report of Aquaculture in the Slaney River Valley SAC, the Raven Point Nature Reserve SAC, the Wexford Harbour and Slobs SPA and the Raven SPA, in August 2016.

A literature review of published papers relating to the effects of mussel culture on water column nutrient levels was carried out as part of the Technical Advisors Final Report (Section 8.0 of the February 2025 Technical Advisors Final Report).

Following on from the findings of the literature review and noting the judgment of the Court of Justice of the European Union (CJEU) in the case of Eco Advocacy v An Bord Pleanála (Case C-721/21) referred to in the submissions made by T.L. Mussels Ltd., it is my opinion that any potential reduction in water column nutrient levels in Wexford Harbour associated with the bottom cultivation of mussels cannot be considered grounds to negate the obligations to carry out an Appropriate Assessment as required under Article 6(3) of the Habitats Directive 92/43/EEC.

Even if mussel denitrification could be considered to be a standard feature inherent in the project which can be considered at screening stage within the meaning of the Eco Advocacy judgment, Appropriate Assessment is still required because the potential impacts of the project are not primarily related to water quality issues.

# Step 2 - Identification of relevant Natura 2000 sites using Source-Pathway-Receptor Model and compilation of information on qualifying interests and conservation objectives.

The Qualifying Interests (QI's) highlighted in **bold text** are screened in for Stage 2 Appropriate Assessment. Distances are measured as straight-line distances in open water, or along-shore coastal distances, depending on the site and QI's being considered.
