Re: Save Ballyness Bay S.A.C. Action Group and Brian Farrell v The Aquaculture Licences Appeals Board and the Minister for Agriculture, Food and the Marine and Seamus O' Donnell High Court No 2024 1062 JR and High Court No 2024 1063 JR (the "Proceedings")

Dear Mr O'Donnell,

The above Proceedings were issued to challenge the Determinations of the Aquaculture Licence Appeals Board (ALAB), which confirmed the Minister for Agriculture, Food and the Marine's decision to grant with variation a licence to you for the cultivation of Pacific Oysters using bags and trestles on inter-tidal foreshore on Site Refs: T12/455A (AP9/2020) and T12/455B (AP10/2020).

ALAB decided not to oppose orders quashing these Determinations and advised the parties that it would not oppose remittal of the appeals to ALAB should the licence applicant request remittal to ALAB.

It is noted that you did not request remittal of your appeals to ALAB. The above Determinations were accordingly quashed *simpliciter* and the High Court Orders (enclosed) do not provide for remittal of the appeals to ALAB for reconsideration.



Should you wish to carry out an aquaculture activity in the future, you must therefore submit a new aquaculture licence application to the Minister for Agriculture, Food and the Marine.
