

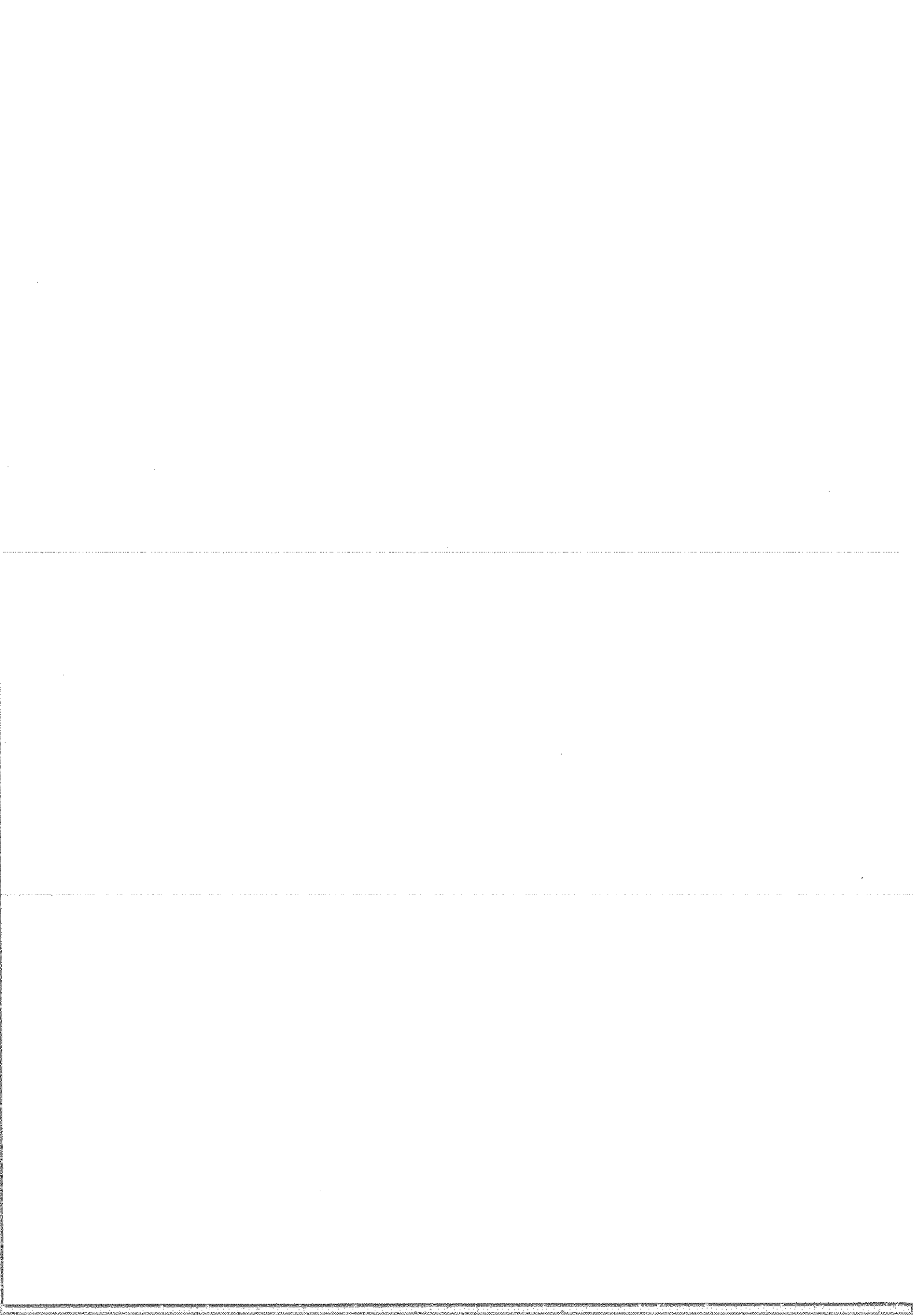

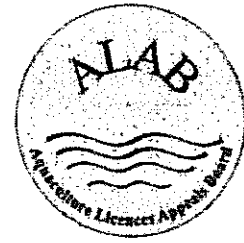

I refer to the appeals received by ALAB in relation to Aquaculture Licence for the cultivation of Atlantic Salmon; *Salmo Salar* on a site on the foreshore at Shot Head, Bantry Bay, Co Cork.

In considering the Report and recommendations of the Chair of the Oral Hearing conducted in connection with these appeals, the Board, pursuant to Section 47(1) (a) of the Fisheries (Amendment) Act, 1997, now requires the following information for the purposes of enabling it further consider and determine the Appeal:

That a supplemental Environmental Impact Statement (EIS) be undertaken, supplemental to the Environmental Impact Statement (EIS) of May 2011 included in the Minister's File for these appeals, which addresses the following issues:

1. The Risk of sea-lice infestation of wild salmonids migrating from/to the Dromagowlane and Trafask rivers and any resulting implications for local freshwater pearl mussel populations; and
2. The impact of salmon farm waste on water quality in Bantry Bay, having particular regard to the maintenance of 'good water status' as required under the Water Framework Directive

In accordance with section 47 (1) (a) of the Act, the Board requires this information within 3 months of the date of receipt of this letter.
